The future 96th Street Station will have three entrances with 10 escalators and one ADA accessible elevator from street level. The construction in this area involved heavy civil/structural work for the 96th Street Station which was completed in November 2013.

The follow-on contract is underway and will include the building of the station structure, systems, and finishes. This follow-on contracted will be complete in Summer 2016.

Construction Update

LEVEL SURFACE

- Ancillary 1 (northeast corner of 93rd Street and Second Avenue)—Concrete pours for basement walls, cap beam, street slab, and street level. Formwork installation for the first floor slab
- Ancillary 2 (southwest corner of 97th Street and Second Avenue) -Completed waterproofing for roof and cap beam. Formwork installation for the first floor slab.
- Continued utility installations to include gas, water, electric and telephone on the east side of Second Avenue this month. Decking panels will be removed in conjunction with this work followed by backfilling of the roadway.
- Intermittent street closings will occur on E. 93rd, 94th, and 95th Streets between First and Second Avenues. E. 94th Street also will be intermittently closed between Second and Third Avenues. These closures are necessary to support construction of the ancillary buildings and entrances and only take place as needed.

Underground

- Entrance 1 (southwest corner of 94th Street and Second Avenue) waterproofing installation was completed. Installation of formwork and rebar for the stairs is in progress.
- Entrance 2 (northeast corner of 94th Street and Second Avenue) – Poured the street slab and escalator ramp. Installation of rebar for the walls is in progress.
- Entrance 3 (southwest corner of 96th Street and Second Avenue) – Installation of walls is ongoing
